

## **CONFIDENTIALITY POLICY**

**GUINEA GOLD TRUST** pays much attention to protecting the personal data of its customers. Buyers of Units, Gold Certificates and EnergoBonds on the site ggold-trust.com can view the site without reporting any personal data about themselves. However, to provide services related to the purchase of Units, Gold Certificates and EnergoBonds on the site, we need your contact information.

### **1. General Provisions**

1.1. This Privacy Policy establishes the procedure for obtaining, storing, processing, using and disclosing the personal data of the Buyer. Personal data of the Buyer we receive from the Buyer when making a purchase of Units, Gold Certificates and EnergoBonds through the site's cart, when placing an order on the phone indicated on the site, and when registering by the Buyer himself (creating an account). Personal data of the Buyer shall be filled by the Buyer (when registering the purchase of Units, Gold Certificates and EnergoBonds through the site or when registering on the site). The information required for providing the service is marked in a special way. Other information is provided by the Buyer at its discretion.

1.2. For registration of purchase of Units, Gold Certificates and EnergoBonds through a site basket the Buyer should:

- carefully read this Privacy Policy (hereinafter referred to as the Policy);
- in the form of buying Units, Gold Certificates and EnergoBonds the Buyer himself fills in the necessary personal data (name, email address, contact phone number).

1.3. The buyer does not have the right to use ggold-trust.com, namely, to register the purchase of Units, Gold Certificates and EnergoBonds and register, if he does not agree with the terms of this Privacy Policy.

1.4. Making a purchase of Units, Gold Certificates and EnergoBonds by registering on ggold-trust.com website and submitting personal data or providing these data via the telephone number indicated on the site, the Buyer gives its unequivocal consent to the terms of this Privacy Policy. The user grants GUINEA GOLD TRUST the right to receive, store, process and use his personal data on the terms of this Privacy Policy.

1.5. The buyer acknowledges that in the event of a negligent attitude by the Buyer himself to the safe storage of his data, third parties may gain unauthorized access to the database and personal and other data of the Buyer. GUINEA GOLD TRUST is not liable for damages caused by such access.

### **2. What personal data do we collect?**

2.1 We collect personal data, namely: name, contact phone number, e-mail address etc. We can also clarify and receive this information from you by phone.

2.2 Other information is provided by the Buyer at its discretion.

2.3 The site ggold-trust.com does not collect IP-addresses of users.

### **3. Objectives of collecting and processing user's personal data**

3.1 ggold-trust.com collects and stores only those personal data that are required to provide services for the purchase of Units, Gold Certificates and EnergoBonds of GUINEA GOLD TRUST.

3.2 ggold-trust.com collects data for maintaining the register of beneficiaries of GUINEA GOLD TRUST.

### **4. Conditions for granting access to the database**

4.1 We do not transfer the personal data of the Buyer to third parties except as provided by the legislation of United Kingdom.

4.2 Disclosure of the personal data of the Buyer is made when purchasing by the Buyer of Units, Gold Certificates and EnergoBonds on the site [ggold-trust.com](http://ggold-trust.com) only to the extent necessary for the identification of the Buyer and only by the site administrator who has the right to process personal data of the Buyers.

## **5. Changing the user's personal information**

The buyer can at any time change (update, supplement, delete) the personal information provided to him or her part.

## **6. Using cookies**

Website uses the technology of user identification, based on the use of cookies. Cookies are small text files stored on your computer through a web browser. If the User uses the Site on the computer used by him for access, cookies may be recorded, which will be used subsequently to automatically authorize the User on the Site, as well as to collect statistical data, in particular about the attendance of the Site. In this case, we never save personal data or passwords in cookies. If you still believe that for one reason or another the use of cookies is unacceptable for you, you may prohibit the saving of cookies on the computer used to access the Site by properly configuring the browser. It should be borne in mind that all services on the Internet using this technology will be inaccessible.
